The Inter-American Development Bank has received financing from the Inter-American Development Bank (IDB), and intends to apply part of the proceeds to payments under the project Substitution of Fossil based Electricity Generation with Renewable Energy, for a consulting firm to provide specialized advisory services in the area of renewable energy. An international consulting firm with presence in Central America and the Caribbean will be hired under a retainer contract to carry out demand driven pre-investment studies for Renewable Energy projects (solar PV, biogas, wind power, hydropower, and diverse renewable thermal technologies such as solar and geothermal).

The Inter-American Development Bank now invites eligible consultants to indicate their interest in providing the services. Interested consultants must provide information establishing that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc). Consultants may associate to enhance their qualifications.

Consulting firms shall send their Expressions of Interest (EOI) with not more than fifteen (15) pages (including Annexes) written in English language and including: (i) legal name of the Consulting Firm; (ii) legal representative properly authorized to sign the declaration for and on behalf of the Firm; (iii) address; (iv) telephone number and fax; (v) e-mail address of contact person and website; (vi) information about the Consulting Firm organization and its principal areas of expertise and activities; (vii) proven aptitude to develop technical and financial/economic feasibility assessments for RE, (viii) proven aptitude to develop on-site measurements for RE projects. The information requested in (vi), (viii), (viii) should include, as a minimum: a description of the activities, the degree or percentage of participation in the project, the execution period and dates, the level of responsibility held by the company in each project (technical, supervision or administrative responsibility), the country and region with the location of the project. The curricula vitae of potential personnel involved in the studies are not required at this stage.

Experience in Central America or the Caribbean islands will be desirable. Working language of the consultancy will be both English and Spanish.

Consultants will be selected in accordance with the procedures set out in the Inter-American Development Bank: 0Policies for the selection and Contracting of Consultants financed by the Inter-American Development Bank00 (current edition) and is open to all eligible bidders as defined in the policies.
